Violation #10. Handwashing sinks, accessible & supplies

At the time of this inspection, a trash can was observed missing in the handwashing sink. Provide trash can. Person in charge provided a trash can. Corrected Onsite.

CODE REFERENCE: 64E-11.003(5)(d). Handwashing sinks are properly equipped with hand soap, individual disposable towels or hand drying device, and signage; and conveniently located.

Violation #21. Hot holding temperatures

At the time of this inspection, cheese pizza(119F) was observed out temperature inside the warmer. Food products in hot holding shall be 135F or up. Reheated food at least to 165F. Person in charge reheated the Pizza(176F). Corrected Onsite.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

Violation #56. Ventilation & lighting

At the time of this inspection, the mechanical ventilation in the employee's restroom was observed with dust accumulation. Clean and sanitize mechanical ventilation.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
